**AFFILIATED COMPUTER SVCS INC (ACS) Pending Merger with XEROX CORP (XRX)**

On Friday, February 05, 2010, the shareholders of Affiliated Computer Svcs Inc (ACS) voted and approved the proposed merger with Xerox Corp (XRX). If the merger is approved and consummated, each ACS share will be converted into the right to receive 4.935000 XRX Common Shares and \$18.60cash. Cash will be paid in lieu of fractional XRX shares. **The merger became effective after the close of business today, February 5, 2010**

**Pending Contract Adjustments**
